## Terms and Conditions of PB Oversea Remittance Campaign

1. The PB Oversea Remittance Campaign is provided by Public Bank Berhad of Malaysia (“Public Bank Berhad”) in association with Public Bank (Hong Kong) Limited (“Public Bank Hong Kong”).
2. Campaign period is from 1 April 2018 to 31 December 2018.
3. During the campaign Period:
  - 3.1 The applicant for the oversea remittance service remitting fund through Public Bank Berhad directly to Hong Kong (“the Remittance Transaction”), the remittance fee is reduced to RM10 Flat (the standard fee is RM32 as of 1 April 2018) for each Remittance Transaction.
  - 3.2 Subject to satisfaction of the clause 3.1 above, if the beneficiary of the Remittance Transaction is the account holder of Public Bank Hong Kong and the amount is credited directly to the account maintained with Public Bank Hong Kong, the inward remittance fee is reduced to HK\$30 for each Remittance Transaction (the standard fee is HKD60 as of 1 April 2018)
4. Public Bank Berhad and Public Bank Hong Kong reserve the right to terminate the above privileges at any time or to vary the same and the related terms and conditions from time to time without prior notice. Should any disputes arise, the decision of Public Bank Berhad shall be final and conclusive. In case of any discrepancy between the English and Chinese versions, the English version shall always prevail.
